MAYOR'S ADDRESS

Mayor's Address – State of the Borough:

Distinguished guests, members of the Borough Council, Ladies and Gentlemen, Neighbors and Friends.

Good evening and welcome to the 2020 Reorganization Meeting for the Borough of Far Hills. As we begin 2020, let me first take this opportunity to wish you and your family's health, happiness and prosperity in the year to come.

As we begin 2020, I want to thank the residents of Far Hills for their continued support of me and this Council, of whom I am very proud. I want to also congratulate Council President David Karner on his re-election this past November and to welcome Councilman Ted McLean as the newest member of the Council. I thank the Council for working collaboratively and utilizing their strengths and talents for the betterment of all the residents of Far Hills. I also want to thank the members of the Planning Board, Board of Health and all our professionals who contribute so much to the Borough. To our Administration, our Borough Clerk Dorothy Hicks and to her staff who go above and beyond to ensure that the business of government runs smoothly. To our Chief of Police Michael DeCarolis and his team of talented and dedicated officers who safeguard our Borough and its residents.

Before we look forward to 2020, let's take a brief look back. 2019 was an extremely busy year, the majority of which was dedicated to Affordable Housing. Working collaboratively with our professionals, especially our Borough Attorney Joseph Sordillo and our Borough Planner David Banisch, we have worked diligently to address our Supreme Court mandated responsibilities, a mandate which has been a topic of great debate and discussion, not only here in Far Hills but throughout the state of New Jersey. We have made great progress and will continue to secure the best possible outcome for our residents through working with our residents while also adhering to the Courts constant oversight.

We have completed the Douglas Road Improvements project, working collaboratively with our neighbors in Bernards Township and will continue to do this in 2020 with the Minebrook Road Improvements project. Through the utilization of grants from the NJDOT we are being ever mindful of completing these expensive projects with the least impact on our taxpayers.

2019 saw the completion of two successful VNA Rummage Sales which helps to benefit our residents in need of medical support.

The Essex Horse Trials and the Far Hills Race Meet were both very well attended providing monies for various charities in and around our area, that benefit our residents. In conjunction with our Police

Department and surrounding police and county forces, we have continued to make this a much more family friendly and enjoyable equestrian event.

For the third year in a row, our municipal tax rate continues to be one of the lowest in the state of New Jersey, something we are very proud of and work hard to maintain. By utilizing cooperative purchasing, monitoring and certifying the number of school children and maximizing shared service agreements with our neighboring municipalities, I and this Council will continue to be extremely fiscally prudent. I want to thank our CFO Debi Stern and our auditors Nisivoccia for their guidance as well.

Due to the tremendous efforts of Council President Karner and Councilman Carty, we have a new five year PBA contract with our police force continuing to provide our residents with the officers they know and trust, which is very important to our residents, all while being fiscally prudent.

2019 saw some personnel changes and to those who have retired or relocated, we wish them well. We extend a warm welcome our new employee, Shana Goodchild as Planning Board secretary.

So what lies ahead as we begin the new decade? In 2020, we are working with our Construction Department to obtain software that will enhance our ability to monitor projects throughout the Borough and streamline and further implement new state requirements. Proposals are currently being reviewed. We will continue to work with our police department to provide the latest software programs and technology to augment those already in place and which upgrades are required by state and national enforcement agencies.

We will continue to move forward with the final components of our Affordable Housing obligation and we will, over the next several months, fully satisfy the Courts and Fair Share Housing Centers requirements so that Far Hills is protected through court immunity. We will continue to do so with public input and in a fiscally responsible and esthetically pleasing manner.

We will continue to improve the Borough website which has made excellent progress and will do so without subjecting the Borough to tens of thousands of dollars in technical support and IT costs to the taxpayer. Again, I want to thank Dorothy Hicks for her efforts here.

Plans are in place to address drainage issues in town, which are planned to commence in the spring. Additionally, the drainage issues at the Fairgrounds will also be reviewed. Plans are also in the works to enhance the Fairgrounds and Councilman Hand will be spearheading those initiatives.

We continue to maintain an independent court system which is financially positive for the Borough and I thank Councilwoman Chimenti for her input. I also want to thank Councilwoman Tweedie who will be beginning a video impact study of the Borough's sewer system in order to fix leaks and address issues which, in turn reduce our long term costs.

We will continue to preserve the charm and character of our Borough, to remember its history and to prepare for our 100th anniversary celebration which will happen in April of 2021. Council President Karner and my wife, Janis will co-chair that event. I also want to thank my wife Janis for her continuing support which is invaluable.

In conclusion, Far Hills continues to be in excellent health, and I, this Council and administration will continue to work with you the residents, to hear your thoughts and ideas so we can continue to work

together going forward in a positive manner. By doing so, we can surmount any challenge and together very confidently move into 2020.
